
OFFICE ORDER No.115 /2025

In continuation to this Directorate's Office Memorandum no. 22-27/1/2020-PER-DGS dated 06.08.2025 regarding the offer of appointment to the post of Engineer and Ship Surveyor-cum-Deputy Director General(Technical), and to state that the same has been accepted by Shri Joseph Jegan Xavier Martin, vide his communication received through email dated 06.08.2025.

2. Accordingly, with the approval of the Competent Authority, Shri Joseph Jegan Xavier Martin is hereby appointed provisionally to the post of Engineer and Ship Surveyor-cum-Deputy Director General (Technical) in Level-12 (₹78,800-₹2,09,200) of the Pay Matrix, with initial basic pay of ₹78,800/-, plus usual allowances as admissible under the rules to Central Government servants in that grade from time to time until further orders. The appointment shall take effect from the date he assumes charge of the post.

3. Shri Joseph Jegan Xavier Martin is hereby posted at Mercantile Marine Department, Haldia. He is directed to report for duty before the Principal Officer, MMD, Kolkata forthwith, under intimation to this Directorate.
