**OFFICE ORDER NO. 71 of 2026**

In supersession of Office Order No. 143 of 2024 dated 26.11.2024 and pursuant to the administrative review of manpower deployment in the office of the National Shipping Board, New Delhi, the Competent Authority has ordered that Shri Jitendra S. Jadhav, Assistant Director General of Shipping, shall look after the following responsibilities with immediate effect and until further order:
